- ServiceNow Utah moved to Prohibited status
- Microsoft Dynamics 365 2023 Release Wave 2, 23x moved to Divest: Plan status

Data management technology roadmap

- Microsoft SQL server
 - Version 2012 - out of support in 2022 and removed from the roadmap
 - Version 2014 is end of support and it is not listed in Archer as a current application
- Oracle
 - 19c is Prohibited
 - Oracle Reports and APEX tool info has been added to the Oracle section
- MySQL
 - v8.0.35 – moved to Divest: Execution because it is Prohibited as of April 2025 and end of support one year later
- Mongo DB
 - A row was added for Mongo DB 8.0 as emerging, general availability (GA) is October 2024
 - Mongo DB 7.0 is on release 7.3
- ArcGIS Enterprise
 - v10.9.1 is Divest: Plan and will be Divest: Execution in Dec. 2024
- SAP
 - Business objects 4.3 is Divest: Plan and will be Divest: Execution in Dec. 2024
 - Business objects 4.2 is Prohibited
- SAS
 - Version 9.4, release m7 is Divest: Execution and will be Prohibited in Dec. 2024
 - Version 9.4, release m4 has been removed because it has been out of support since 2021
- R Core reference was deleted as it is not in Archer
- Microstrategy
 - Version 2021x release June 2024 is N-1

- Version 2021x release Sept. 2024 is approved as N
- Note: Releases for this application are monthly
