



Mandatory



- 1. Enterprise Applications & Projects Centrally administered applications which act as the authoritative source of data or processing for the Commonwealth.
- 2. Collaborative Applications, Services & Projects Business applications and services which provide organizations and/or political subdivisions the opportunity to work together, in a substantive, mutually beneficial relationship, with a common integrated solution.
- 3. Mandatory Projects Projects that support legal or regulatory requirements such as Executive Orders, state legislation, or Federal mandates
- 4. **Operational Projects (Run the Business)** A project portfolio category for projects that support business functionality, deliverables, or processes by correcting or modifying existing assets. These projects do not introduce new functionality.
- 5. Enhancements (Improve the Business) A project portfolio category for projects that support business functionality, deliverables, or processes by enhancing existing assets. These projects can introduce new processes.
- 6. Transformational Projects (Transform the Business) A project portfolio category for projects that support business functionality, deliverables, or processes by changing the way an organization does business.
